

NOTICE

Notice is hereby given that, pursuant to the provisions of the Pennsylvania Municipalities Planning Code and the Act governing Townships of the First Class, both as amended, the Board of Commissioners of Lower Pottsgrove Township intends to hold a public hearing on December 1, 2008 at 6:00 p.m., and a public meeting immediately thereafter at the Lower Pottsgrove Township Building, 2199 Buchert Road, Pottstown, Pennsylvania, to consider amendments to the Lower Pottsgrove Township Zoning Ordinance and Map as set forth herein.

The proposed ordinances, if enacted, will amend and revise the official Zoning Map of Lower Pottsgrove Township and, in addition to making substantive changes to the Zoning Ordinance, shall be effective December 1, 2008.

NOW THEREFORE, BE IT ORDAINED AND ENACTED AND IT IS HEREBY ORDAINED AND ENACTED by the Board of Commissioners of Lower Pottsgrove Township, Montgomery County, Pennsylvania as follows:

Section 1. Intent. It is the intent of this Ordinance to repeal and replace, in their entirety, all existing provisions of the Zoning Ordinance regulating the Gateway-Interchange (G-IN) Zoning District, currently Part 21.

Section 2. Part 21. Gateway Interchange (G-IN) District. A new Part 21 of the Zoning Ordinance is hereby enacted entitled "Part 21: Gateway Interchange (G-IN) District" and shall read as follows:

ORDINANCE NO. 283

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF LOWER POTTS GROVE, MONTGOMERY COUNTY, PENNSYLVANIA REPEALING IN ITS ENTIRETY PART 15: LIMITED COMMERCIAL (LC) DISTRICT OF THE LOWER POTTS GROVE TOWNSHIP ZONING ORDINANCE, ADDING AS PART 15, THE GATEWAY MIXED-USE (G-MU) DISTRICT AND AMENDING §2605. PERMITTED SIGNS AND RESTRICTIONS

ORDINANCE 287

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF LOWER POTTS GROVE, MONTGOMERY COUNTY, PENNSYLVANIA AMENDING THE ZONING MAP OF LOWER POTTS GROVE TOWNSHIP BY CHANGING THE ZONING CLASSIFICATION OF CERTAIN TRACTS OF GROUND LOCATED IN THE TOWNSHIP OF LOWER POTTS GROVE TO PROVIDE FOR THE UNDERLYING ZONING DISTRICTS OF GATEWAY MIXED-USE (G-MU) AND SR-4 SUBURBAN RESIDENTIAL AND AMEND THE BOUNDARIES OF THE R-1 RESIDENTIAL, R-2 RESIDENTIAL, R-3 RESIDENTIAL, LIMITED INDUSTRIAL (LI) AND GATEWAY INTERCHANGE (G-IN) DISTRICTS AND DELETE THE LIMITED COMMERCIAL (LC) DISTRICT

WHEREAS, the Board of Commissioners of Lower Pottsgrove Township desires to extend the G-IN Gateway Interchange District into certain areas currently zoned LC-Limited Commercial (also shown as LCD) and R-3 Residential;

WHEREAS, the Board of Commissioners of Lower Pottsgrove Township desires to extend the R-1 Residential District into certain areas currently zoned R-3 Residential;

WHEREAS, the Board of Commissioners of Lower Pottsgrove Township desires to extend the R-2 Residential District into certain areas currently zoned R-3 Residential;

NOW, THEREFORE, be it enacted and ordained by the Board of Commissioners of Lower Pottsgrove Township, Montgomery County, Pennsylvania, and it is hereby enacted by the Authority of the same, that the Lower Pottsgrove Township Code of Ordinances, Ordinance 192 of 1995, as amended, is further amended as follows:

Section 1. LC-Limited Commercial. The LC-Limited Commercial District (also shown as LCD) is hereby removed from the Zoning Map of Lower Pottsgrove Township.

Section 2. R-1 Residential to G-MU Gateway Mixed-Use. The Zoning Map of Lower Pottsgrove Township is hereby amended to remove the following properties from the R-1 Residential District and include them in the new Gateway Mixed-Use District classification.
